

shall be subject within the Area of Concurrent Jurisdiction to the orders and directions of the Dade County Public Safety Department. The Tribe reserves the right to withdraw its officers from the Area of Concurrent Jurisdiction when the Dade County Public Safety Department arrives at the scene or there is a requirement for police services of a more urgent nature within the Tribal Use Area.

3. Only persons holding current certificates of compliance issued by the Florida Commission on Police Officer Standards and Training will be permitted to act outside of the Tribal Use Area pursuant to the provisions of this Agreement.

4. The Miccosukee Public Safety Department will advise the County immediately concerning all incidents within the Area of Concurrent Jurisdiction in which police action is taken and/or a report is written pursuant to the provisions of this Agreement. Notification is not required in traffic enforcement.

5. In any such case, the Miccosukee Public Safety Department will, prior to the arrival of County officers:

- a. Render first aid to the injured;
 - b. Preserve the scene;
 - c. Contain victims, witnesses and suspects;
 - d. Detain or arrest suspects;
 - e. Document observations and spontaneous statements;
- in order of importance, depending upon the circumstances prevailing.

6. The Miccosukee Public Safety Department will not interrogate

suspects without the express permission of the Dade County Public Safety Department.

7. The Miccosukee Public Safety Department will notify the Florida Highway Patrol as soon as possible concerning all traffic accidents coming to its attention on U.S. Highway 41 (New Tamiami Trail) or other roads within the Area of Concurrent Jurisdiction.

8. The Miccosukee Public Safety Department is expressly granted concurrent traffic enforcement jurisdiction within the boundaries of the Area of Concurrent Jurisdiction over all roads other than U.S. Highway 41 (New Tamiami Trail).

9. Except as expressly provided otherwise herein, the Miccosukee Public Safety Department may make arrests for violation of state and county laws and apply for and serve arrest warrants and search warrants (but not the civil process of state or county courts), and officers qualified under paragraph 3 may engage in fresh pursuit of persons leaving the Tribal Use Area or the Area of Concurrent Jurisdiction in the same circumstances in which municipal officers may engage in fresh pursuit pursuant to Fla. Stat. SS901.25.

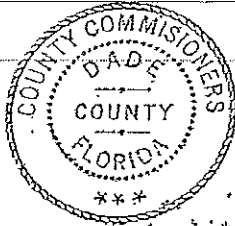
10. The Tribe will keep in force comprehensive liability insurance in the minimum amount of \$250,000 for each person and \$500,000 for each occurrence, payable for contract law enforcement services rendered outside of the Tribal Use Area.

11. The Tribe expressly assumes full responsibility as an independent contractor for the acts of its police officers committed while performing under the terms of this Agreement, except during such times as said police officers are under the direction and control of the County.

The parties further covenant and agree to cooperate with each other in all aspects of law enforcement within Area of Concurrent Jurisdiction and in all other matters of mutual interest.

This Agreement may be terminated upon service of written notice of termination by either party upon the other as of the date specified in such notice which shall be not less than three days from the date notice is served. The Tribe will deliver any notice of termination to the Commander, West District, Dade County Public Safety Department, and the County will deliver any notice of termination to the Director, Miccosukee Public Safety Department, or his designee.

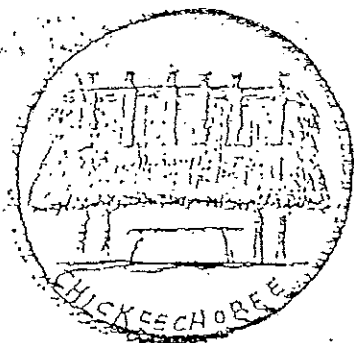

NOW; THEREFORE, BE IT RESOLVED, that the proposed agreement between Metropolitan Dade County, Florida, and the Miccosukee Tribe of Indians of Florida attached hereto and incorporated by reference herein be, and hereby is, approved and the Chairman of the Tribe be, and hereby is, authorized to sign the agreement on behalf of the Tribe; provided that the agreement is approved and signed by the appropriate official of Metropolitan Dade County.

FURTHER RESOLVED, that the Miccosukee Business Council hereby requests the government of Metropolitan Dade County to approve and sign the agreement attached hereto.

On December 4, 1978, the Board approved
which authorized the Miccosukee Tribe of
exercise concurrent police jurisdiction with the Metro-Dade
Police Department to enforce state and county law within the
area north of Old Tamiami Trail and south of District Levee 29.
Due to the relatively remote location of these county areas,
they are not routinely patrolled by the Metro-Dade Police
Department. As a result of the close geographical proximity of
the Miccosukee Tribe of Indians of Florida to this area, it was
determined that it was in the best interest of the County to
authorize concurrent police jurisdiction.

On October 19, 1982, the Board approved Amendment R-1498-82, to
the 1978 Agreement. This agreement extended the concurrent
police jurisdictional areas to include that portion of U.S. 41
which was located within the boundaries of the 1978 agreement
jurisdictional area, but which was excluded from the concurrent
jurisdiction provisions of that agreement.

Currently, the Miccosukee Tribe of Indians of Florida has
proposed an amendment which will again extend the area of
concurrent police jurisdiction. The Miccosukee Business

proposal. The amendment will permit the Miccosukee Police
Department to exercise concurrent police jurisdiction along U.S.

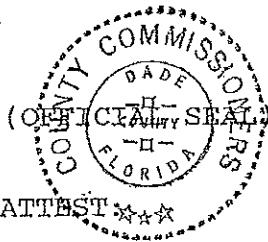

WITNESSETH THAT:

1. The Agreement is amended by adding to the area of concurrent jurisdiction the following area, described as:

Beginning at a point on the west right of way line of an existing road in Section 19, Township 54 South, Range 36 East, known as Seven Mile Road, and its intersection with the north right of way line of District Levee 29, thence east along the north right of way line of District Levee 29, to the east right of way line of L67C District Levee, thence south along the east right of way line L67C District Levee to the south right of way line of the Old U.S. 41, also known as the Old Tamiami Trail, thence west along the south right of way line of the Old U.S. 41 to the west right of way line of the aforementioned Seven Mile Road, and then north along the west right of way line of Seven Mile Road to the north right of way of District Levee 29. Additionally, the entire right of way between the north and south right of way lines of U.S. 41, from the L67C District Levee eastward to the easternmost boundary of the Osceola Indian Camp, and the Osceola Indian Camp that lies immediately south of the U.S. 41 and east of the north eastern boundary of Everglades National Park,

2. In each pertinent part of the agreement dated December 5, 1978, and the amendment thereto of October 19, 1982, the name Miccosukee Police Department should be substituted for the name Miccosukee Public Safety Department.
3. In all other respects the Agreement is hereby ratified and confirmed.

- WHEREAS, ~~the Miccosukee Tribe of Indians of Florida is an Indian Tribe organized under the provisions of the Federal Indian Reorganization Act, 25 U.S.C. § 476, and is authorized to exercise governmental jurisdiction within the Tribal Use Area reserved by the Secretary of the Interior for the occupancy of the Tribe, and~~
- WHEREAS, the Tribe has heretofore entered into an agreement, dated December 5, 1978, with Metropolitan Dade County providing for the exercise of certain law enforcement jurisdiction as defined in the Agreement, which is located immediately adjacent to the Tribal Use Area; and
- WHEREAS, On December 31, 1982 the Congress of the United States passed Public Law 97-399 better known as the Florida Indian Land Claims Settlement Act of 1982. The Act provides for the perpetual lease of Everglades land granted by the State of Florida to the Miccosukee Tribe; and
- WHEREAS, Florida Statute 285.17 provides the leased area be included within the special improvement district within which the Miccosukee Tribe is authorized to exercise law enforcement authority under state law; and
- WHEREAS, Miccosukee Police Officers when patrolling the southern boundry of the leased area must operate their patrol vehicles on U.S. 41 in an easterly direction to the L67C District Levee and then return; and
- WHEREAS, the Tribe, the Florida Highway Patrol, and the Metropolitan Dade County Police Department agree that the public interest will be served by extending the eastern boundry of the present agreement to the L67C District Levee;

NOW THEREFORE, BE IT RESOLVED, that the Miccosukee Tribal Business Council hereby requests that the present agreement be amended to include the following described area; Beginning at a point on the west right of way line of an existing road in Section 19, Township 54 South, Range 36 East, known as Seven Mile Road, and its intersection with the north right of way line of District Levee 29, thence east along the north right of way line of District Levee 29, to the east right of way line of L67C District Levee, thence south along the east right of way line L67C District Levee to the south right of way line of the Old U.S. 41, also known as the old Tamiami Trail, thence west along the south right of way line of the old U.S. 41 to the west right of way line of the aforementioned Seven Mile Road and then north along the west right of way line of Seven Mile Road to the north right of way line of District Levee 29. Additionally, the entire right of way between the north and south right of way lines of U.S. 41 from the L67C District Levee eastward to the easternmost boundry of the Osceola Indian Camp, and the Osceola Indian Camp that lies immediately south of the U.S. 41 and east of the north eastern boundry of Everglades National Park, and which is clearly marked on the ground. As a result of the close geographical proximity of the Miccosukee Tribe of Indians of Florida to this area, it was determined that it was in the best interest of the County to authorize concurrent police jurisdiction.

On October 19, 1982, the Board approved Amendment R-1498-82, to the 1978 Agreement. This agreement extended the concurrent police jurisdictional areas to include that portion of Tamiami Trail (U.S. 41) which was located within the boundaries of the 1978 agreement jurisdictional area, but which was excluded from the concurrent jurisdiction provisions of that agreement.

On December 6, 1988, the Board approved Amendment R-1550-88, to the 1978 Agreement. This agreement further extended the Miccosukee Police Departments' concurrent jurisdiction to include the area along U.S. 41 from Seven Mile Road east to the L67 District Levee, and on the site of the Osceola Indian Camp.

Currently, the Miccosukee Tribe of Indians of Florida has proposed an amendment which will again extend the area of concurrent police jurisdiction. The amendment will permit the Miccosukee Police Department to exercise concurrent police jurisdiction over an area defined as the entire right-of-way of U.S. 41 from a point 1500 feet west of the west lateral line of Krome Avenue (S.R. 997), to and including the entire intersection of the right-of-way of U.S. 41 and S.R. 997, and the entire right-of-way of S.R. 997, from the north lateral line of U.S. 41 north for a distance of 1500 feet.

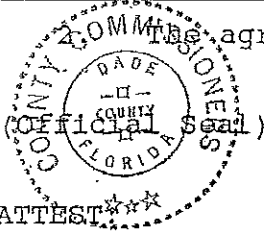

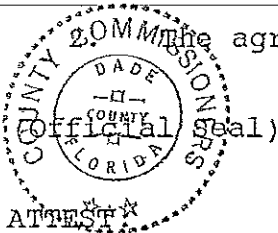
THIS AMENDMENT, dated the 19th day of February, 1991, between Metropolitan Dade County, Florida (hereinafter referred to as "County") and the Miccosukee Tribe of Indians of Florida (hereinafter referred to as "Tribe") to the agreement between the County and the Tribe, dated December 5, 1978, as amended on October 19, 1982 and December 6, 1988.

WITNESSETH THAT:

1. The Agreement is amended by adding to the area of concurrent jurisdiction the following area, described as the area bounded by a line beginning at a point in Section 1, Township 54 South, Range 38 east Dade County, Florida on the south lateral line of the Tamiami Trail U.S. 41 right-of-way situated 1500 feet west of the west lateral line of the Krome Avenue S.R. 997 right-of-way, eastbound along the south lateral line of the U.S. 41 right-of-way to its intersection with the east lateral line of the S.R. 997 right-of-way, then northbound along the east lateral line of the S.R. 997 right-of-way to a point 1500 feet north of the north lateral line of the U.S. 41

right-of-way, then westbound to a point on the west lateral line of the S.R. 997 right-of-way located 1500 feet north of the north lateral line of U.S. 41, then southbound along the west lateral line of the S.R. 997 right-of-way to its intersection with the north lateral line of the U.S. 41 right-of-way, then westbound along the north lateral line of the U.S. 41 right-of-way to a point 1500 feet west of the west lateral line of the S.R. 997 right-of-way, then southbound to a point on the south lateral line of U.S. 41 situated 1500 feet west of the west lateral line of the S.R. 997 right-of-way.

The agreement is hereby ratified and confirmed.



RECOMMENDATION

It is recommended that the Board approve the attached resolution authorizing the County Manager to execute the attached Amendment to the 1978 Agreement between Miami-Dade County and the Miccosukee Tribe of Indians of Florida to permit the Miccosukee Police Department to exercise concurrent police jurisdiction. This Amendment will extend the area of concurrent police jurisdiction along U.S. 41 (Tamiami Trail) from L67 District Levee east to State Road 997 (Krome Avenue).

BACKGROUND

On October 17, 1978, the Board approved Resolution No. R-1232-78, which authorized the execution of an Agreement between Miami-Dade County and the Miccosukee Tribe of Indians of Florida to permit the Miccosukee Police Department to exercise concurrent police jurisdiction to enforce state and county law within the area north of Old Tamiami Trail and south of District Levee 29. Due to the relatively remote location of these county areas, they are not routinely patrolled by the Miami-Dade Police Department. As a result of the close proximity of the Tribe to this area, it was determined that it was in the best interest of the County to authorize concurrent police jurisdiction.

During the past few years, the Board has approved three amendments to the 1978 Agreement. The first amendment was approved on October 19, 1982, under Resolution No. 1498-82. This amendment extended the concurrent police jurisdictional areas to include that portion of U.S. 41, which was located within the boundaries of the 1978 Agreement jurisdictional area, but which was excluded from the concurrent jurisdictional provisions of that agreement. The second amendment, approved on December 6, 1988, under Resolution No. R-1550-88, further extended the Miccosukee Police Department's concurrent jurisdiction to include the area along U.S. 41 from the Seven Mile Road east to the L67 District Levee, and on the site of the Osceola Indian Camp. Finally, on February 19, 1991, the Board approved the third amendment under Resolution No. R-171-91, extending the police jurisdictional areas to include 1500 feet north, south, east, and west of the intersection of State Road 997 and U.S. 41.

Currently, the Tribe has proposed a fourth amendment that will again extend the area of concurrent police jurisdiction. This amendment will permit the Miccosukee Police Department to exercise concurrent police jurisdiction along U.S. 41 from the L67 District Levee east to State Road 997.

The reasons for the proposed amendment include similar circumstances as stated in the 1978 Agreement, which was established in an effort to improve law enforcement services outside tribal jurisdiction and adjacent to the Tribe's lands, where a significant portion of the Miccosukee community live and work. The Tigertail Camp, which consists of various homes, is located east of the main Reservation boundary, and within the requested area of concurrent police jurisdiction. Additionally, the recent opening of the Miccosukee Convention Center and Resort has augmented the number of calls for assistance and enforcement with the increase of tourism traffic in the area. It has been determined that due to the close proximity of the Tribe to this area and the fact that the Miccosukee Police Department is making substantially increased number of daily trips to the convention center, it will be in the best interest of the County to authorize concurrent police jurisdiction.

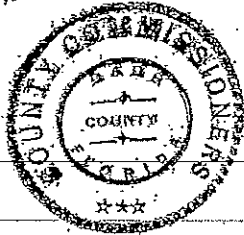

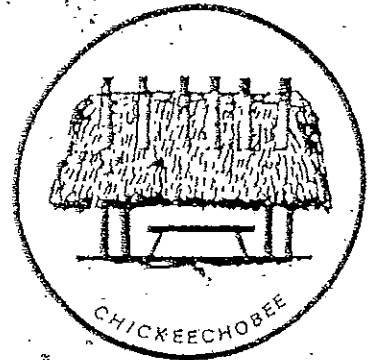

WHEREAS, on July 21, 1999 the Director of the Miami-Dade Police Department approved the attached amendment to the 1978 Concurrent Jurisdiction Agreement again extending the area of concurrent jurisdiction; and

WHEREAS, the Miccosukee Tribe wishes to continue to cooperate with the government of Miami-Dade County with respect to law enforcement matters in the vicinity of the



AMENDMENT

THIS AMENDMENT, dated the 2ND day of Nov, 1999, between Miami-Dade County, Florida (hereinafter referred to as "County") and the Miccosukee Tribe of Indians of Florida (hereinafter referred to as "Tribe") to the agreement between the County and the Tribe, dated December 5, 1978, as amended on October 19, 1982, as amended on December 6, 1988, and February 19, 1991.

WITNESSETH THAT:

1. The Agreement is amended by adding to the area of concurrent jurisdiction the following area, described as the area bounded by a line beginning at a point where the east right of way line from the L67C District Levee meets with the north right of way line of the District Levee 29, thence east along the north right of way line of District Levee 29 to the east right of way line of District Levee L-30, thence south along the east right of way line of District Levee 30 continuing such line to the north right of way line of U.S. 41 (Tamiami Trail), thence east along the north right of way line of U.S. 41 to the east right of way line of S.R. 997 (Krome Avenue), thence south along the east right of way line of S.R. 997 to the south right of way line of U.S. 41, thence west along the south right of way line of U.S. 41 to the east right of way line of L67C District Levee, thence north along the

east right of way line of the L67C District levee to the point of beginning. Said legal description will also include those properties commonly known as Coopertown, Gator Park, and Everglades Safari found along the south right of way line of U.S. 41.

2. The parties recognize that the Tribe, being a federally recognized Indian tribe, is a sovereign entity dedicated to promoting the general welfare of its tribal members and to conserving and developing its lands and resources to secure for its members and their descendants the blessings of liberty and freedom. Nothing in this Agreement or amendments thereto, shall be construed to limit or diminish that sovereignty nor to abridge or waive any sovereign rights, privileges or immunities of the Tribe, its agencies, including the Miccosukee Police Department (MPD), divisions, corporations, and commercial enterprises or their respective officers and representatives.

3. Nothing in this Agreement or amendments thereto, shall be construed to limit or diminish the sovereignty nor to abridge or waive any sovereign rights, privileges or immunities of the County, its agencies, including the Miami-Dade Police Department (MDPD), divisions, corporations, and commercial enterprises or their respective officers and representatives.

4. The agreement is hereby ratified and confirmed.
